

INFORMATIVE CLAUSE

Dear Participants,

ensuring the confidentiality and transparency of the processing of personal data and in accordance with fair information practices and the applicable provisions of Regulation (EU) 2016/679 of the European Parliament and Council (EU) 2016/679 of 2016, April 27, on the protection of individuals in connection with the processing of personal data and on the free flow of such data and the repeal of Directive 95/46 / EC (general regulation on data protection), hereinafter referred to as "GDPR", we would like to inform you that the administrator of your personal data is the Military University of Technology (hereinafter referred to as the University) with its registered office in Warsaw at the address: gen. Sylwestra Kaliskiego 2, 00-908.

1. Your personal data will be processed in connection with the organization of the International Armament Congress entitled "Scientific Aspects of Armament Technology and Security" (hereinafter referred to as the "Congress") for the purpose of carrying out necessary organizational tasks, such as: managing participation, communication, promotion, and documentation of the Congress.
2. The legal basis for the processing of your personal data are:
 - Article 6(1)(a) GDPR, i.e. consent to the processing of personal data in connection with participation in Congress, which we consider to be voluntary filling in of the registration form,
 - Article 6(1)(a) of the GDPR, i.e. consent to the processing of personal data, including the image in connection with the promotion of the Congress and the use of data in the University's promotional materials, which we consider to be personal participation in the Congress,
 - Article 6(1)(a) of the GDPR, i.e. consent to the processing of personal data, in order to send you information about future congresses and other similar events organized by the Military University of Technology, which will be expressed by filling in the appropriate field in the registration form,
 - Article 6(1)(c) and (e) of the GDPR in connection with the investigation or defence against possible claims,
 - Article 6(1)(e) GDPR in connection with the organization by the University of scientific events carried out as part of public tasks and their documentation and information about such events.
3. Providing personal data in the registration form is voluntary, but necessary to participate in the Congress.
4. Your personal data will be disclosed to the Operational Centre of the Minister of National Defence in connection with the application for the Minister's patronage and the related post-congress report, as well as to entities authorized by law.
5. By participating in the Congress, you acknowledge that your personal data, including your image, may be published on the University's and Congress's websites, related social media channels, and in materials produced in connection with the Congress.
6. Your personal data will be processed for the duration of the Congress and its organization, and subsequently for the establishment, exercise, or defence of legal claims, or until your consent is withdrawn.
7. You have the right to withdraw your consent at any time without affecting the lawfulness of processing based on consent before its withdrawal. You may withdraw your consent by sending an email to the Organizing Committee at: mku@wat.edu.pl.

8. You have the right to request access to, rectification, or erasure of your personal data, as well as the restriction of processing. Please note that the right to object to processing does not apply when the processing is based on your consent or compliance with a legal obligation.
9. You have the right to lodge a complaint with the supervisory authority, i.e., the President of the Office for Personal Data Protection.
